BY-LAW NO. 123

**A BY-LAW TO PROVIDE FOR THE DETERMINATION OF VARIOUS
PROCEDURES FOR THE CONDUCT OF LOCAL GOVERNMENT
ELECTIONS AND OTHER VOTING**

WHEREAS under Part 3 of the Municipal Act, the Council may, by By-Law, determine various procedures and requirements to be applied to the conduct of local government elections and other voting;

AND WHEREAS Council wishes to establish various procedures and requirements under that authority;

NOW THEREFORE, the Council of the District of Highlands, in open meeting assembled, enacts as follows:

1. VOTING DAY REGISTRATION ONLY

- (a)** As authorized under Section 54 of the Municipal Act, for the purposes of all elections and other voting under Parts 3 and 4 of the Municipal Act, a person may register as an elector only at the time of voting.
- (b)** Registration as an elector under Section 1. (a) of this By-Law is effective only for the voting or other matters on which the opinion of the electors is being sought at the time of voting.

2. REQUIRED ADVANCE VOTING OPPORTUNITIES

- (a)** As provided under Section 97 of the Municipal Act, the required advance voting opportunity will be held on the 10th day before general voting day from 8:00 a.m. to 8:00 p.m. for each election or other voting.
- (b)** The advance voting opportunity referred to in Section 97 (2) (b) of the Municipal Act will not be held for each election or other voting.

3. ADDITIONAL ADVANCE VOTING OPPORTUNITIES

- (a) In addition to the required advance voting on the 10th day before general voting day, under Section 98 of the Municipal Act, the Council authorizes the chief election officer to establish additional voting opportunities in advance of general voting day for each election and designate the voting places and set the voting hours for these voting opportunities.

4. RESOLUTION OF TIE VOTES AFTER JUDICIAL RECOUNT

- (a) In the event of a tie vote after a judicial recount, the tie vote will be resolved by conducting a lot in accordance with Section 141 of the Municipal Act.

5. REPEAL OF BY-LAWS

"District of Highlands Elections By-Law No. 46, 1995" is hereby repealed.

6. CITATION

This By-Law may be cited for all purposes as "The District of Highlands General Local Government Election By-Law No. 123, 1999".
