

DISTRICT OF HIGHLANDS

BY-LAW NO. 86

A By-Law of the District of Highlands to merge the Eastern Highlands Fire Protection Specified Area and the Western Highlands Specified Area

WHEREAS Specified Areas for the purpose of providing Fire Protection Services for the District of Highlands were established by the following:

Capital Regional District - By-Law No. 1537 - "Eastern Highlands Fire Protection Specified Area Establishment By-Law No. 1, 1987", and any amendments thereto.

Capital Regional District - By-Law No. 2076 - "Langford Electoral Area Fire Protection and Emergency Response Local Service By-Law No. 1, 1993", and any amendments thereto.

AND WHEREAS Council may by By-Law, pursuant to the terms of Section 650 of the Municipal Act, merge two or more specified areas into one specified area for the purposes specified in the By-Laws establishing them;

NOW THEREFORE the Council of the District of Highlands, in open meeting assembled, ENACTS AS FOLLOWS:

1. That the specified areas including debt, created by:

Capital Regional District - By-Law No. 1537 - "Eastern Highlands Fire Protection Specified Area Establishment By-Law No. 1, 1987"

Capital Regional District - By-Law No. 2076 - "Langford Electoral Area Fire Protection and Emergency Response Local Service By-Law No. 1, 1993";

Capital Regional District By-Law No. 2133 "Langford Electoral Area Fire Protection and Emergency Response Local Service Amendment By-Law No. 1, 1993";

District of Highlands By-Law No. 38 "Fire Protection Specified Area Amendment By-Law No. 38, 1995";

District of Highlands By-Law No. 41 "Fire Protection Specified Area Amendment By-Law No. 41, 1995;

District of Highlands By-Law No. 48 "East Highlands Fire Protection Specified Area Amendment By-Law No. 48, 1995"

are hereby merged to form the new "District of Highlands Fire Specified Area" shown outlined in heavy black line on the map attached hereto as Appendix "A" and forming part of this By-Law.

2. This By-Law may be cited for all purposes as the "District of Highlands Fire Specified Area Merger By-Law No. 86, 1997".
