CYCLING RACES ON MILLSTREAM ROAD/CALEB PIKE ROAD Council has approved nine cycling races to be held by the Schwalbe Cycling Club this spring and summer. The course will begin on Millstream at Caleb Pike (at the Pike House), travel north on Millstream and turn right onto Caleb Pike Road at the north end, then back around to Millstream Road. The Club will provide course marshalls and traffic controllers during each event and pylons will mark the centreline and corners. Event times and dates will be posted around the area, and the Club will provide proof of

insurance to the district. The first race will be held from 10 am - 12:30 pm on March 28th, and thereafter will be held on Wednesday evenings beginning on April 14th (from 5 pm - 7:30 pm) and continuing every second Wednesday (from 5:30 - 8 pm) thereafter until July 28th. On committee meeting nights, the Club has been asked to park their vehicles on Caleb Pike Road on the west side of Millstream Road. If you have any concerns or if any problems occur, please contact the municipal office.

LOCAL GOVERNMENT ELECTION ISSUES The Local Government Elections Task Force is reviewing local government election issues and is seeking comments from Council, organizations and individuals in the community. The Task Force is a joint, consensus-based group of provincial and Union of B.C. Municipalities (UBCM) members. It is co-chaired by the Honourable Bill Bennett, Minister of Community and Rural Development, and Harry Nyce, UBCM President. The Task Force invites comments on any or all of these topics:

- campaign finance, including contribution/spending disclosure and limits, and tax
- enforcement processes and outcomes,
- role of the B.C. Chief Electoral Officer in local government elections,
- election cycle (term of office)
- corporate vote, and
- matters raised in election resolutions submitted to the 2009 UBCM Convention, such as the eligibility of volunteers.

Comments are requested to be submitted by April 15th, and the Task Force will make recommendations by May 30th. Written comments can be made via email to <localelectionstaskforce@gov.bc.ca>, by fax to 250 387 7972, or by mail to:

REDUCING THE RISK OF WILDFIRE Val Fletcher, DoH Emergency Coordinator

Now that it appears we are though the major winter wind storm season it is time to think about protecting your home from wildfire:

- · Start with a general yard cleanup. Within 10 metres of your home, remove trees, needles, branches, deadfall and underbrush that could fuel a fire. Get rid of brush, long grass and anything growing under large nearby trees that could cause a fire to spread into those trees and neighbouring trees. Clean gutters and roofs of organic debris.
- Prune low-level branches up to at least 2.5 metres above the ground. Replace bark mulch with gravel or decorative rocks.
- Move your woodpile and other flammable materials away from your house or other buildings. Flammable materials should be at least 10 metres away and uphill from your home.
- If your home is on a slope, pay particular attention to the downhill side of your property. Fire can race uphill and burn trees, brush, grass or other flammable
- Please consult local regulations prior to undertaking any work (e.g. Highlands Tree Management Bylaw No. 10)

More detailed information on how to reduce the risk of loss, damage, or injury from wildfire is contained in a pamphlet titled The Home Owners Fire Smart Manual, available at the District Office or on our web site at:

The Highlands Volunteer Fire Department would like to remind residents that a permit is required year round for burn piles measuring 1m x 1m or greater, and for machine made piles. Permits are required for ANY fire after April 1st, or before that date if the fire hazard rating changes. Check the district website for up to date information regarding open and other burning, observe the signs posted at each road entrance to Highlands, or phone the Acting Fire Chief before you burn; see the back page for contact information.

COUNCIL STRATEGIC PLANNING

Strategic planning for 2010 will include recommendations from the final report of the Sustainability Task Force, which included a suggested action plan to begin to address sustainability issues which include land use and OCP policy items, groundwater monitoring issues, operational and communication items, and political action items. Since there are many recommendations to be included, Council will hold a council/staff planning workshop in the near future to further discuss prioritizing the many items on the strategic planning list. Some of the Sustainability Task Force recommendations have been referred to the Groundwater Task Force, for possible inclusion in Phase 3 of the Groundwater Monitoring Program.

SOLAR DIGESTERS provide an alternative to disposing of your kitchen waste in the household trash, **reducing the amount of material going from a household to the landfill by 30%!** Different than a composter, digesters decompose foods not suited to backyard composting, such as dairy, meat scraps, bones, and cooked food by using both solar heat and bacteria in a speeded up process. Pet droppings can also be disposed of in a safe and convenient way using a digester. OFFICIAL COMMUNITY PLAN AMENDMENTS The Capital

Regional District Board has formally accepted Highlands Regional Context Statement. The statement is required by every municipality in the CRD and is included in Official Community Plans (OCP). It highlights how each municipality will comply with the Regional Growth Strategy (RGS). The RGS is a regional plan accepted unanimously by municipal councils and by the CRD board in 2003 to contain urban areas and protect agricultural and rural areas in the region, largely by setting a boundary beyond which piped services would not be allowed.

When the Bear Mountain property in Highlands was rezoned, Highlands requested an extension of the boundary, a request that was eventually settled by a provincially- appointed arbitrator. Though the entire property was not included, the boundary was extended to include a portion of the property. Highlands council now is required to amend our OCP to incorporate the newly-accepted Regional Context Statement, which includes the arbitrated services boundary.

Council is also required to amend the OCP by May 31st (by Provincial legislation) to include targets, policies and actions to reduce greenhouse gas (GHG) emissions in Highlands. Planner Jon Munn made a presentation to Council on February 15th to explain the requirements and the process. According to the Ministry of Community and Rural Development's Target Workbook, targets are typically expressed as either a percentage or number of tonnes reduction, and must be community-wide.

Last term, Council signed on to the Climate Action Charter, setting a target for municipal corporate operations to be carbon-neutral by 2012. The goal is to reduce green- house gas emissions. Where it's not possible, GHG emissions must be offset by payment to an offsetting organization. GHG emissions are calculated on a carbon equivalent per tonne basis.

Council directed staff to return with policy options in order to proceed with the OCP amendment to meet the May deadline. It is expected that the regional context statement will be included at the same time. The recommendations from staff will be discussed in a future Committee-of-the-Whole meeting to which select committees will be invited.

HIGHLANDS HISTORY - DID YOU KNOW? Duncan Ross bought

Section 25 around Pease Lake in the late 1890's and in 1910 built his family a summer home there on the lake. By 1918 Mrs. Ross, now a widow, moved herself and their young children to the lake house permanently. The girls had to go to school and if they attended the Highland School at Millstream and Millstream Lake Roads, the school could stay open as the Ross girls would make up the required minimum of eight pupils. Mrs. Ross borrowed a two wheeled cart and horse from neighbour Frederick Corry; her daughter Mary (10 years old) drove her sister Margaret (8 years old) the four and a half miles through the woods to the school every day. When the old horse died, the girls' Highland school days came to an end and Mrs. Ross moved them all back to Victoria for a "proper education".
