# **Highlands Fire Department Receives Another 5 Year Superior Shuttle Accreditation Certificate**



The Fire Department has completed the requirements for another five year certificate from the Fire Underwriters Survey. The FUS approved Superior Shuttle Accreditation for both fire halls.

After a day long visit from a FUS representative last month, it was determined that with our excellent practical test in 2017 and consistent level of yearly training in water shuttling, combined with the District's commitment in maintaining the required level of fire equipment and water sources, the practical portion of the accreditation was not required this time. ~ Fire Chief Ford

At Council's March 7 meeting, it referred the STEP CODE staff report to the Sustainable Land Use Select Committee (SLUSC), which considered the report on March 23. SLUSC resolved to encourage Council to select an approach for Step Code in Highlands that is ahead of the Building Code implementation of the Step Code and is in line with the higher steps adopted in the leading municipalities. Council had further discussion and invited public comment at the April 11 Committee of the Whole meeting. The recommendation that was adopted at the subsequent Council Meeting was:

That staff prepare a report on the implications of implementing the following BC Step Code approach:

- Require Step 3 as a condition for new standard (Part 9) residential buildings less than 75m2
- Require Step 4 as a condition for new standard (Part 9) residential buildings 75m2 to 300m2
- Require Step 5 as a condition for new standard (Part 9) residential buildings greater than 300m2 including alignment with applicable District of Highlands bylaws, provincial legislation, and incorporation of low carbon energy systems (LCES) incentives.

#### **2022 Property Tax Notices and Financial Plan Update**

In May, Highlands Council adopted the 2022-2026 Financial Plan. Please contact the District Office with any questions that you may have regarding the Financial Plan. You can view the final 2022 budget online: 2022 – 2026 Financial Plan.

2022 Property Tax Notices have now been mailed to property owners in the District of Highlands. Payment is due by July 4, 2022 to avoid penalties being applied to your account. ## Mount Work Regional Park Management Plan Process

CRD is finalizing its first management plan for Mount Work Regional Park that will provide both strategic and specific management direction and will guide environmental conservation, cultural heritage management, visitor use and park development over the next 15 years. Approximately half of the park is in Highlands. Council provided initial input in 2020. This topic was further discussed at the May 9, 2022 Committee of the Whole meeting where CRD's Park Planner provided a presentation and responded to questions. Council resolved to provide the CRD with a letter that summarized community and council comments providing a low level of support for the draft plan. Key points included: need for ecological inventory, enforcement plan, and commitment regarding decommissioning unsanctioned cycling trails.

#### **Protecting Birds Pamphlet**

The Spring Newsletter included advice on how to protect birds from cats and collisions with glass. #### Rezoning of 587 / 499 Millstream Road

The applicants are seeking additional residential density in exchange for conserving some of the land that is currently used as managed forest. The property contains the historic Mitchell Cottage. It is a complicated application because the land is currently classified as Managed Forest through BC Assessment. The application is headed to the Heritage and Sustainable Land Use Select Committees for recommendations.

# Secondary Suites and Accessory Dwelling Units Project

In the spring, Council considered updates to the draft policy and staff is now drafting a zoning bylaw amendment and any companion policy(ies) for Council consideration.

#### **Be Bear and Cougar Aware**

It is a contravention of the Wildlife Act to knowingly put out attractants to predatory wildlife. The BC Conservation Officers note that households should put their garbage out on the morning of scheduled pick up. People may be ticketed by Conservation Officers if garbage is put out the night before pick up. These tickets start at approximately \$275.00 and go up to \$575.00 for a second offence.

The outcome for the wildlife can sometimes be deadly due to Provincial Policy in the Wildlife Act directing the Conservation Officers. Let's help the animals by doing our part to protect them.

#### **Highlanders Helping Ukrainians Get Support (or Highland HUGS)**

On April 27, a group of Highlanders met to discuss ways we could support Ukrainian refugees coming to Vancouver Island. Bryan Melnyk from the Ukrainian Cultural Centre gave a talk on the hosting program in Victoria, which was followed by an interactive workshop on ideas for supporting hosts. There was great enthusiasm amongst the group, and we adopted the name Highland HUGS and agreed to explore ways Highlanders could help support Ukrainians.

My husband and I were among the first Highlanders to host a family through HelpukraineVI. Our Ukrainian family arrived May 2 and were with us for almost three weeks. They are a lovely family with a 12-year-old daughter and are extremely motivated to find jobs and improve their English.

Before long though, we realized that hosting a family without access to public transport would significantly impair their ability to get to jobs and social activities. Reluctantly, we realized we needed to find them another host closer to the bus system and found them a wonderful family at Bear Mountain.

We learned a tremendous amount during our preparations and hosting, which I am happy to share with anyone interested. For starters, you will find our summary of "lessons learned" in an article on the HDCA Facebook page.

What can Highlanders do if they can't host a family? I think that Highland HUGS can continue to support hosts. We can be available to help families that do make the decision to host a family. 





#### THREE STEPS TO COST-EFFECTIVE WILDFIRE HOME PROTECTION

Complete these 3 steps to reduce the risk of a wildfire spreading to your home. For items listed under step 3 check with your municipality about any permit requirements and the availability of subsidies. Give decks, sheds and outbuildings within 10 m of your home the same FireSmart consideration as you do your home.


#### STEP 1: MAINTAIN WHAT YOU'VE GOT AT LEAST TWICE PER YEAR

#### 2022 General Local Election - October 15, 2022

Are you thinking of running for District of Highlands Council? General Local Elections are this Fall.

A person qualified to be nominated, elected, and to hold office as a member of local government must meet the following criteria:

- Canadian citizen
- 18 years of age or older on general voting day October 15, 2022
- Resident of BC for at least 6 months immediately before the day nomination papers are filed
- Not disqualified under the *Local Government Act* or any other enactment from voting in an election in BC or being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

The period for candidates to submit their nominations to local election officials is Tuesday, August 30, 2022 – Friday, September 9, 2022, and General Voting Day is Saturday, October 15, 2022.
